

Chapter 1: Hardware Setup

Getting to know your Notebook PC

Top View

NOTE: The keyboard's layout may vary per region or country. The Notebook view may also vary in appearance depending on the Notebook PC model.

Array microphones

The array microphones feature echo canceling, noise suppression, and beam forming functions for better voice recognition and audio recording.

Ambient light sensor

The ambient light sensor detects the amount of ambient light in your environment. It allows the system to automatically adjust the brightness of the display depending on the ambient light condition.



Camera

The built-in camera allows you to take pictures or record videos using your Notebook PC.



Camera indicator

The camera indicator lights up when the built-in camera is in use.



Display panel

This high-definition display panel provides excellent viewing features for photos, videos, and other multimedia files on your Notebook PC.



Keyboard

The keyboard provides full-sized QWERTY keys with a comfortable travel depth for typing. It also enables you to use the function keys, allows quick access to Windows[®], and controls other multimedia functions.

NOTE: The keyboard layout differs by model or territory.



Capital lock indicator

This indicator lights up when the capital lock function is activated. Using capital lock allows you to type capitalized letters (such as A, B, C) using your Notebook PC's keyboard.

ASUSPRO SensePoint

The ASUSPRO SensePoint is a pressure-sensitive pointing device that allows you to move the cursor onscreen. You may also configure its settings to enable the functions of a regular mouse.

NOTE: For more details, refer to the Using the ASUSPRO SensePoint section in this manual.



Touchpad with buttons

The touchpad allows the use of multi-gestures to navigate onscreen, providing an intuitive user experience. It also simulates the functions of a regular mouse.

NOTE: For more details, refer to the Using ASUSPRO SensePoint with the touchpad buttons section in this manual.



Power button

Press the power button to turn your Notebook PC on or off. You can also use the power button to put your Notebook PC to sleep or hibernate mode and wake it up from sleep or hibernate mode.

In the event that your Notebook PC becomes unresponsive, press and hold the power button for at least four (4) seconds until your Notebook PC shuts down.

Keyboard as numeric keypad

These set of keys toggles between their actual key functions and as numeric keys.

NOTE: For more details, refer to the *Keyboard as numeric keypad* section in this manual.



Fingerprint sensor

This built-in fingerprint sensor captures your fingerprint and uses it as biometric authentication for logging on to your Notebook PC's system and other programs inside Windows® 10.


NOTE: For more details, refer to the *ASUS Fingerprint* section in this manual.

Bottom

NOTE: The bottom side may vary in appearance depending on model.

WARNING! The bottom of the Notebook PC can get warm to hot while in use or while charging the battery pack. When working on your Notebook PC, do not place it on surfaces that can block the vents.

IMPORTANT! Battery time varies by usage and by the specifications for this Notebook PC. The battery pack cannot be disassembled.



Docking station pin slots

Insert the pins on your docking station into these slots to securely attach it to your Notebook PC.

Docking station hook slots

Align the hooks on your docking station over these slots then gently insert the hooks to securely attach the docking station to your Notebook PC.



Air vents

The air vents allow cool air to enter and warm air to exit the Notebook PC.

WARNING! Ensure that paper, books, clothing, cables, or other objects do not block any of the air vents or else overheating may occur.



Audio speakers

The built-in audio speakers allow you to hear audio straight from your Notebook PC. Audio features are software-controlled.




Compartment cover

This cover protects the reserved spaces in your Notebook PC for the removable SSD (M.2 2280 slot), HDD (Hard Disk Drives), RAM (Random-Access Memory) modules, and the micro SIM card (on selected models).

NOTE:

- For more details on how to replace or install the HDD and RAM modules of your Notebook PC, refer to the Chapter 5: Upgrading your Notebook PC section of this E-Manual.
- The M.2 2280 slot does not support M.2 PCIe SSD.

Right Side



Memory card reader

This built-in memory card reader supports SD card formats.



USB 3.0 port

The USB 3.0 (Universal Serial Bus 3.0) port provides a transfer rate up to 5 Gbit/s and is backward compatible to USB 2.0.



LAN port


Insert the network cable into this port to connect to a local area network.



Kensington[®] security slot

The Kensington[®] security slot allows you to secure your Notebook PC using Kensington[®] compatible Notebook PC security products.

Left Side



Power (DC) input port

Insert the bundled power adapter into this port to charge the battery pack and supply power to your Notebook PC.

WARNING! The adapter may become warm to hot while in use. Do not cover the adapter and keep it away from your body while it is connected to a power source.

IMPORTANT! Use only the bundled power adapter to charge the battery pack and supply power to your Notebook PC.



USB 3.0 port with USB Charger+

The USB 3.0 (Universal Serial Bus 3.0) port provides a transfer rate of up to 5 Gbit/s and is backward compatible to USB 2.0. The 4 icon indicates this port's USB Charger+ feature which allows you to quick-charge mobile devices.



USB 3.0 port

The USB 3.0 (Universal Serial Bus 3.0) port provides a transfer rate up to 5 Gbit/s and is backward compatible to USB 2.0.



VGA port

This port allows you to connect your Notebook PC to an external display.



Mini DisplayPort


This port allows you to connect your Notebook PC to an external display.



Headphone/Headset/Microphone jack

This port allows you to connect amplified speakers or headphones. You can also use this port to connect your headset or an external microphone.

Status indicators

The status indicators help identify the current hardware status of your Notebook PC.



♀ Power indicator

The power indicator lights up when the Notebook PC is turned on and blinks slowly when the Notebook PC is in sleep mode.

Two-color battery charge indicator

The two-color LED provides a visual indication of the battery's charge status. Refer to the following table for details:

Color	Status
Solid White	The Notebook PC is plugged to a power source and the battery power is between 95% and 100%.
Solid Orange	The Notebook PC is plugged to a power source, charging its battery, and the battery power is less than 95%.
Blinking Orange	The Notebook PC is running on battery mode and the battery power is less than 10%.
Lights off	The Notebook PC is running on battery mode and the battery power is between 10% to 100%.

Drive activity indicator

This indicator lights up when your Notebook PC is accessing the internal storage drives.

(p) Bluetooth / Wireless indicator

This indicator lights up when your Notebook PC's wireless function (Bluetooth or Wi-Fi) is enabled.



Smart card reader

This Notebook PC has a built-in memory card reader slot that supports smart card formats.

Chapter 2: Using your Notebook PC

Getting started

Charge your Notebook PC

- A. Connect the AC power cord to the AC/DC adapter.
- B. Plug the AC power adapter into a 100V~240V power source.
- C. Connect the DC power connector into your Notebook PC's power (DC) input.



Charge the Notebook PC for **3 hours** before using it in battery mode for the first time.

NOTE: The power adapter may vary in appearance, depending on models and your region.



IMPORTANT!

Power adapter information:

- Input voltage: 100-240Vac
- Input frequency: 50-60Hz
- Rating output current: 3.42A (65W)
- Rating output voltage: 19V

IMPORTANT!


- Locate the input/output rating label on your Notebook PC and ensure that it matches the input/output rating information on your power adapter. Some Notebook PC models may have multiple rating output currents based on the available SKU.
- Ensure that your Notebook PC is connected to the power adapter before turning it on for the first time. We strongly recommend that you use a grounded wall socket while using your Notebook PC on power adapter mode.
- The socket outlet must be easily accessible and near your Notebook
 PC.
- To disconnect your Notebook PC from its main power supply, unplug your Notebook PC from the power socket.

WARNING!



- Only ASUS-authorized technicians should remove the battery inside the device (for non-removable battery only).
- The battery used in this device may present a risk of fire or chemical burn if removed or disassembled.

Moving the pointer

You can tap anywhere on the touchpad to activate its pointer, then slide your finger on the touchpad to move the pointer onscreen.

Slide horizontally



Slide vertically



Two-finger gestures

Bring together your two fingers on the touchpad.



Spread apart your two fingers on the touchpad.

Drag and drop



Select an item then press and hold the left button. Using your other finger, slide on the touchpad to drag the item, lift your finger off the button to drop the item.

Using the ASUSPRO SensePoint

Your Notebook PC comes with the ASUSPRO SensePoint which can be used to move the mouse pointer or cursor onscreen. You can also use this to simulate the functions of a regular mouse.

Configuring the settings

Refer to the following information for details on how to enable left-click or right-click functions, dragging, and the Release-to-Select function of your ASUSPRO SensePoint:

- 1. Open Control Panel > Mouse.
- 2. From the Mouse Properties dialog box, Select the ASUS Touchpad tab then select ASUSPRO SensePoint.
- 3. Click Options.

4. Select either of the following items to enable their functions:



Enable Dragging - This allows you to drag and drop items onscreen using the ASUSPRO SensePoint.

Enable Release-to-Select - This enables the Release-to-Select function of your ASUSPRO SensePoint.

Press Z-axis - This allows you to simulate the left-click or rightclick functions of a mouse using the ASUSPRO SensePoint.


5. Select **OK** to save and exit or **Cancel** to exit without saving.

ASUSPRO SensePoint features

Moving the cursor onscreen

Press and hold down on the ASUSPRO SensePoint, then move your finger to the direction where you want to move the cursor onscreen.

IMPORTANT! The ASUSPRO SensePoint is pressure-sensitive. The more pressure you apply, the faster it moves the cursor onscreen.



Using ASUSPRO SensePoint with the touchpad buttons

Scrolling



To scroll through lists, press-and-hold the middle touchpad button then apply pressure on the ASUSPRO SensePoint towards the direction where you want to scroll through: up/down, left/right.

Selecting onscreen items



Press-and-hold the left touchpad button. Using another finger, apply pressure on the ASUSPRO SensePoint to move the cursor onscreen and highlight the items you want to select.

Right-click features

Refer to the following table when using your ASUSPRO SensePoint to simulate the functions of a right mouse button.

IMPORTANT! Ensure that **Right Click** is enabled on your Notebook PC before enabling the following functions. For more details, refer to the *Configuring the settings* section in this manual.

ASUS FingerPrint

Capture fingerprint biometrics on your Notebook PC's fingerprint sensor using the ASUS FingerPrint app. This app allows you to use fingerprint biometrics as user-authenticated access into your Notebook PC's system and applications.

Using this app, you can enable the following features:

- Swipe your finger over the fingerprint sensor to log on from boot up straight into the Windows® operating system without manually keying in passwords.
- Set up the boot key as backup access for your fingerprint biometrics.
- Import or back up other fingerprint biometrics you would like to use to log on to your Notebook PC and its system programs.

Using the ASUS FingerPrint app

Create your fingerprint biometrics using the following steps:

1. Launch the Apps screen then click on the **ASUS FingerPrint** icon from the list of applications under **ASUS**.



2. Click **Register** to create a new fingerprint account.



3. Key in your user account password then click **OK**.



4. Click the 💽 on the finger illustration that corresponds to the same finger you would like to use as your fingerprint biometric data.



5. Swipe your designated finger twice on the fingerprint sensor to create your fingerprint biometric data.



6. 1 and 2 changes to blue to indicate that the fingerprint was successfully captured. Click **Next** to proceed.

7. Create your boot key password in the next window to serve as backup access for your fingerprint biometric data.

Configure your boot key settings and fingerprint biometrics using the basic and advanced options of the ASUS FingerPrint settings.

Accessing the ASUS FingerPrint settings

The ASUS FingerPrint settings window appears right after creating your first fingerprint biometric data. Later on, you may also access this window by launching the **ASUS FingerPrint** app from the Start Screen.



The Basic settings of ASUS FingerPrint allows you to configure your current fingerprint biometrics, add more fingerprint biometrics, and change the details of your boot key. It also shows the current status of your Notebook PC's fingerprint sensor.











- 1. Press the power button on your Notebook PC. Wait for a few minutes until the setup screen appears.
- From the setup screen, pick your region and a language to use on your Notebook PC.
- 3. Carefully read the License Terms. Select I accept.
- Follow the onscreen instructions to configure the following basic items:
 - Personalize
 - Get online
 - Settings
 - Your account
- After configuring the basic items, Windows® 10 proceeds to install your apps and preferred settings. Ensure that your Notebook PC is kept powered on during the setup process.
- 6. Once the setup process is complete, the Desktop appears.

Start menu

The Start menu is the main gateway to your Notebook PC's programs, Windows® apps, folders, and settings.



You can use the Start menu to do these common activities:

- Start programs or Windows® apps
- Open commonly used programs or Windows® apps
- Adjust Notebook PC settings
- Get help with the Windows operating system
- Turn off your Notebook PC
- Log off from Windows or switch to a different user account

Launching the Start menu



Position your mouse pointer over the Start button in the lower-left corner of your desktop then click it.

Opening programs from the Start menu

One of the most common uses of the Start menu is opening programs installed on your Notebook PC.





Wi-Fi

Connecting Wi-Fi

Bluetooth

Pairing with other Bluetooth-enabled devices

You need to pair your Notebook PC with other Bluetooth-enabled devices to enable data transfers. Connect your devices by using the following steps:

- 1. Launch **Settings** from the Start menu.
 - Select **Devices**, then select **Bluetooth** to search for Bluetooth-enabled devices.
 - Select a device from the list. Compare the passcode on your Notebook PC with the passcode sent to your chosen device. If they are the same, select Yes to successfully pair your Notebook PC with the device.

NOTE: For some Bluetooth-enabled devices, you may be prompted to key in the passcode of your Notebook PC.

Airplane mode

Airplane mode disables wireless communication, allowing you to use your Notebook PC safely while in-flight.

NOTE: Contact your airline provider to learn about related in-flight services that can be used and restrictions that must be followed when using your Notebook PC in-flight.

Connecting to wired networks

- 11. Select **Close** to finish the configuration.
- 12. Select 🕎 on the taskbar then select the connection you just created.
- 13. Type your user name and password then select **Connect** to start connecting to the Internet.

Chapter 4: Power-On Self-Test (POST)

The Power-On Self-Test (POST)

The POST (Power-On Self-Test) is a series of software-controlled diagnostic tests that run when you turn on or restart your Notebook PC. The software that controls the POST is installed as a permanent part of the Notebook PC's architecture.

Using POST to access BIOS and Troubleshoot

During POST, you can access the BIOS settings or run troubleshooting options using the function keys of your Notebook PC. You may refer to the following information for more details.

BIOS

The BIOS (Basic Input and Output System) stores system hardware settings that are needed for system startup in the Notebook PC.

The default BIOS settings apply to most conditions of your Notebook PC. Do not change the default BIOS settings except in the following circumstances:

- An error message appears onscreen during system bootup and requests you to run the BIOS Setup.
- You have installed a new system component that requires further BIOS settings or updates.

WARNING! Using inappropriate BIOS settings may result to system instability or boot failure. We strongly recommend that you change the BIOS settings only with the help of a trained service personnel.

Accessing BIOS



Restart your Notebook PC then press [10] during POST.

Boot

Recovering your system

Using recovery options on your Notebook PC allows you to restore the system to its original state or simply refresh its settings to help improve performance.

IMPORTANT!

- Backup all your data files before doing any recovery option on your Notebook PC.
- Note down important customized settings such as network settings, user names, and passwords to avoid data loss.
- Ensure that your Notebook PC is plugged in to a power source before resetting your system.

Windows® 10 allows you to do any of the following recovery options:

 Keep my files - This option allows you refresh your Notebook PC without affecting personal files (photos, music, videos, documents).


Using this option, you can restore your Notebook PC to its default settings and delete other installed apps.

 Remove everything - This option resets your Notebook PC to its factory settings. You must backup your data before doing this option.

- Go back to an earlier build This option allows you to go back to an earlier build. Use this option if this build is not working for you.
- Advanced startup Using this option allows you to perform other advanced recovery options on your Notebook PC such as:
 - Using a USB drive, network connection or Windows recovery DVD to startup your Notebook PC.
 - Using Troubleshoot to enable any of these advanced recovery options: System Restore, System Image Recovery, Startup Repair, Command Prompt, UEFI Firmware Settings, and Startup Settings.



Installing the Hard Disk Drive





- It is recommended that you replace the HDD under professional supervision. You may also visit an authorized service center for further assistance.


- A. Loosen the screw from the Notebook PC's compartment cover.
- B. Pull out the compartment cover and remove it completely from your Notebook PC.




C. Remove the screws securing the HDD bay to the compartment.




- D. Use the flap on the HDD bay to pull it out of the compartment.
- E. (Optional) If an HDD is currently installed in your Notebook PC, disconnect the HDD bay from the HDD port as shown in the illustration below.




- F. (Optional) If an HDD is currently attached to the HDD bay, refer to the following steps on how to remove the old HDD:

 - 2. Remove the old HDD from the HDD bay then place it on a flat dry surface with its PCB (printed circuit board) facing up, as shown in the illustration below.





- H. Reattach and secure the HDD with the screws you removed earlier.




- I. Connect the HDD connector to the HDD.
- J. Replace the HDD bay back in the compartment, and push the HDD bay until seated.



- K. Secure the HDD bay with the screws you removed earlier.
- L. (Optional) Align the other end of the HDD connector cable with the system board and press firmly into place.



- M. Align and replace the cover of the compartment.
- N. Reattach and secure the cover using the screw you removed earlier.



Installing a RAM module

Upgrade the memory capacity of your Notebook PC by installing a RAM (Random-Access Memory) module in the memory module compartment.



Useful tips for your Notebook PC

To help you maximize the use of your Notebook PC, maintain its system performance, and ensure all your data are kept secured, here are some useful tips that you can follow:

- Update Windows® periodically to ensure that your applications have the latest security settings.
- Use an anti-virus software to protect your data and keep this updated too.
- Unless absolutely necessary, refrain from using force shutdown to turn off your Notebook PC.
- Always backup your data and make it a point to create a backup data in an external storage drive.
- Refrain from using the Notebook PC at extremely high temperatures. If you are not going to use your Notebook PC for a long period of time (at least a month), we recommend that you take out the battery if the battery is removable.
- Disconnect all external devices and ensure you have the following items prior to resetting your Notebook PC:
 - Product key for your operating systems and other installed applications
 - Backup data
 - Log in ID and password
 - Internet connection information

Hardware FAQs

1. A black dot, or sometimes a colored dot, appears onscreen when I turn on the Notebook PC. What should I do?

Although these dots normally appear onscreen, they will not affect your system. If the incident continues and subsequently affects system performance, consult an authorized ASUS service center.

2. My display panel has an uneven color and brightness. How can I fix this?

The color and brightness of your display panel may be affected by the angle and current position of your Notebook PC. The brightness and color tone of your Notebook PC may also vary per model. You may use the function keys or the display settings in your operating system to adjust the appearance of your display panel.

3. How can I maximize my Notebook PC's battery life?

You can try doing any of the following suggestions:

- Use the function keys to adjust the display brightness.
- If you are not using any Wi-Fi connection, switch your system into Airplane mode.
- Disconnect unused USB devices.
- Close unused applications, especially those that take up too much system memory.

4. My battery charge indicator does not light up. What's wrong?

- Check whether the power adapter or battery pack is attached correctly. You may also disconnect the power adapter or battery pack, wait for a minute, then reconnect them again to the power outlet and Notebook PC.
- If the problem still exists, contact your local ASUS service center for assistance

Why is my touchpad not working? 5.



Press f_n + $\mathbf{F}^{(p)}$ to enable your touchpad.

When I play audio and video files, why can't I hear any sound 6. from my Notebook PC's audio speakers?

You can try doing any of the following suggestions:

- Press $\int f_n + \int_{a_0}^{b_1} f_1$ to turn up the speaker volume.
- Check if your speakers were set to mute. •
- Check if a headphone jack is connected to your Notebook • PC and remove it.

What should I do if my Notebook PC's power adapter gets lost 7. or my battery stops working?

Contact your local ASUS service center for assistance.

8. My Notebook PC cannot do keystrokes correctly because my cursor keeps on moving. What should I do?

Make sure that nothing accidentally touches or presses on your touchpad while you type on the keyboard. You can also disable

your touchpad by pressing $\begin{bmatrix} fn \end{bmatrix} + \boxed{\mathbb{Z}}$

9. Instead of showing letters, pressing the "U", "I", and "O" keys on my keyboard displays numbers. How can I change this?



Notebook PC to turn off this feature and use the said keys for inputting letters.

Software FAQs

1. When I turn on my Notebook PC, the power indicator lights up but nothing appears on my screen. What can I do to fix this?

You can try doing any of the following suggestions:

- Force shutdown your Notebook PC by pressing the power button for at least four (4) seconds. Check if the power adapter and battery pack are inserted correctly then turn on your Notebook PC.
- If the problem still exists, contact your local ASUS service center for assistance.

2. What should I do when my screen displays this message: "Remove disks or other media. Press any key to restart."?

You can try doing any of the following suggestions:

- Remove all connected USB devices then restart your Notebook PC.
- Remove any optical discs that are left inside the optical drive then restart.
- If the problem still exists, your Notebook PC might have a memory storage problem. Contact your local ASUS service center for assistance.

3. My Notebook PC boots slower than usual and my operating system lags. How can I fix this?

Delete the applications you recently installed or were not included with your operating system package then restart your system.

4. My Notebook PC does not boot up. How can I fix this?

You can try doing any of the following suggestions:

- Remove all connected devices to your Notebook PC then
 restart your system.
- If the problem still exists, contact your local ASUS service center for assistance.

5. Why can't my Notebook PC wake up from sleep mode?

- You need to press the power button to resume your last working state.
- Your system might have completely used up its battery power. Connect the power adapter to your Notebook PC and connect to a power outlet then press the power button.

DVD-ROM Drive Information

The DVD-ROM drive allows you to view and create your own CDs and DVDs. You can purchase an optional DVD viewer software to view DVD titles.

Regional Playback Information

Playback of DVD movie titles involves decoding MPEG2 video, digital AC3 audio and decryption of CSS protected content. CSS (sometimes called copy guard) is the name given to the content protection scheme adopted by the motion picture industry to satisfy a need to protect against unlawful content duplication.

Although the design rules imposed on CSS licensors are many, one rule that is most relevant is playback restrictions on regionalized content. In order to facilitate geographically staggered movie releases, DVD video titles are released for specific geographic regions as defined in "Region Definitions" below. Copyright laws require that all DVD movies be limited to a particular region (usually coded to the region at which it is sold). While DVD movie content may be released for multiple regions, CSS design rules require that any system capable of playing CSS encrypted content must only be capable of playing one region.

IMPORTANT! The region setting may be changed up to five times using the viewer software, then it can only play DVD movies for the last region setting. Changing the region code after that will require factory resetting which is not covered by warranty. If resetting is desired, shipping and resetting costs will be at the expense of the user.

Internal Modem Compliancy

The Notebook PC with internal modem model complies with JATE (Japan), FCC (US, Canada, Korea, Taiwan), and CTR21. The internal modem has been approved in accordance with Council Decision 98/482/EC for pan-European single terminal connection to the public switched telephone network (PSTN). Overview

On 4th August 1998 the European Council Decision regarding the CTR 21 has been published in the Official Journal of the EC. The CTR 21 applies to all non voice terminal equipment with DTMF-dialling which is intended to be connected to the analogue PSTN (Public Switched Telephone Network).

CTR 21 (Common Technical Regulation) for the attachment requirements for connection to the analogue public switched telephone networks of terminal equipment (excluding terminal equipment supporting the voice telephony justified case service) in which network addressing, if provided, is by means of dual tone multi-frequency signalling.

Network Compatibility Declaration

Up to now the Notified Body of CETECOM issued several pan-European approvals using CTR 21. The results are Europe's first modems which do not require regulatory approvals in each individual European country.

Non-Voice Equipment

Answering machines and loud-speaking telephones can be eligible as well as modems, fax machines, auto-dialers and alarm systems. Equipment in which the end-to-end quality of speech is controlled by regulations (e.g. handset telephones and in some countries also cordless telephones) is excluded.
